Neighborhood Stabilization Trust Second Allocation (NSP2)

Intent of Funds

Stabilize housing values and properties in neighborhoods heavily impacted by foreclosure, through the purchase and rehabilitation or demotion of foreclosed housing units. Units may be purchased and rehabilitated for resale or rental.

Dollars Involved

Federal Funding - \$2 billion

Colorado State share - To be determined through competitive grant process

Colorado State Government share for competitive grants To be determined Administrative Costs - 10% of grant

Technical Assistance, training, research, monitoring and evaluation – Included in above 10% of grant

Match Requirement

None

Formula-base distribution or competitive process

Funds will be made available on a competitive basis. Housing authorities and nonprofit organizations will be eligible to apply.

Funding plan process including how decisions will be made

- State will convene a meeting of interested applicants, including those parties who submitted \$141 million in "letters of interest" in the previous NSP 1 grant process.
- The Federal Government (HUD) will ultimately determine who and how much will be funded through the grant application.
- 1. The state will provide a template for each potential applicant to complete for inclusion in the NSP 2 Super Grant application.
- 2. The state will employ a grant writer to complete the grant application on behalf and the state and its potential grantees.
